What is EPIC EL?	<p>BioBlend's EPIC EL (EsterLink) Dust Suppressant is a soy-based biodegradable natural ester dust control product uniquely designed to greatly reduce fugitive dust.</p> <p>EPIC EL was developed through a partnership between BioBlend and the North Dakota State University Office of Research and Creative Activity. The United Soybean Board and North Dakota Soybean Council supported this research that resulted in EPIC EL, which is certified as 100% biobased under the U.S. Department of Agriculture's BioPreferred® program.</p>

How much does EPIC EL cost?	This product is competitively priced with traditional types of dust suppressant products and is priced specific to applications. Interested customers can get a specific price quote by contacting Todd Allison at todd.allison@bioblend.com or 218-256-7102.
How is EPIC EL applied?	This product is similar in consistency to water, and therefore, can be sprayed using many types of application equipment. A pressurized spray bar capable of metering the amount of product being applied is ideal.
How much EPIC EL is needed to cover an area?	The application volume is based on quantity of product per square yard. As a rule, approximately 0.4-0.5 gallons of product per square yard.
Is EPIC EL safe?	The U.S. Department of Agriculture's BioPreferred® program certified EPIC EL as 100% biobased. EPIC EL's Safety Data Sheet states that this chemical is not considered hazardous by the 2012 OSHA Hazard Communication Standard, which has been updated to align with the Globally Harmonized System of Classification and Labelling of Chemicals. EPIC EL is not considered to be a carcinogen by the National Toxicology Program of the U.S. Department of Health or listed as a potential carcinogen by the International Agency for Research on Cancer. No component of EPIC EL is restricted under the federal Toxic Substances Control Act.

Is EPIC EL registered with the USDA BioPreferred® Program	Yes, it is.
Is EPIC EL a Renewable Dust Suppressant Product?	Yes, it is. More than 515,000 U.S. farmers plant and harvest soybeans each year, producing an abundant supply of oil used in the manufacturing of this product as well as protein for human foods and livestock feeds.
What is the ideal weather conditions to apply EPIC EL?	Warm, sunny, low humidity days are ideal for quick curing time of this product.
How long does it take to absorb before you can drive over EPIC EL?	Weather conditions affect absorption rates, but in many cases, 15-20 minutes will be adequate.
If I get EPIC EL on my vehicle, what is needed to wash it off?	Due to its 100% biobased chemistry EPIC EL is noncorrosive. In the event someone drives through an uncured treatment application, general soap and water will remove the product from vehicle surfaces.
